That a community services district of the name of "Christian Valley Park Community Services District" has been duly established, with the boundaries stated in the resolution calling said election, which boundaries are particularly set forth in "Exhibit A" attached hereto and incorporated herein by reference;
- 6. That Fhank Cakk ALLEN , Francis Victor

 Brown and HakVEY Dinvick Stanker have received a plurality of the votes cast for three (3) members of said Christian Valley Park Community Services District and are hereby declared elected for the terms to be ascertained according to the provisions of Section 61201 of the Government Code of the State of California;
- 7. That said Christian Valley Park Community Services District is formed for the following purposes:
 - A. To supply the inhabitants of the district with water for domestic use, irrigation, sanitation, industrial use, fire protection and recreation.
 - B. The collection, treatment or disposal of sewage, waste and storm water of the district and its inhabitants.
 - C. The collection or disposal of garbage or refuse matter.
 - D. Protection against fire.
 - E. Public recreation by means of parks, including aquatic parks and recreational harbors, playgrounds, swimming pools or recreation buildings.
 - F. Street lighting.
 - G. Mosquito abatement.
 - H. The equipment and maintenance of a police department or other police protection to protect and safeguard life and property.
 - I. To acquire sites for, construct, and maintain library buildings, and to cooperate with other governmental agencies for library service.
 - J. The opening, widening, extending, straightening and surfacing, in whole or part of any street in such district, and subject to the consent of the governing body of the county or city in which said improvement is to be made.

- K. The construction and improvement of bridges, culverts, curbs, gutters, drains, and works incidental to the purposes specified in subdivision J, subject to the consent of the governing body of the county a city in which said improvement is to be made.
- 8. That this resolution and order shall be entered in the minutes of this Board of Supervisors according to the provisions of Section 61127 of the Government Code of the State of California and the Clerk of this Board is hereby directed to file certified copies of this resolution and order as statements of the creation of said district with the Recorder of the County of Placer, the Assessor of the County of Placer, the Secretary of State of the State of California, and the State Board of Equalization of the State of California.
- 9. That the Clerk of this Board is hereby directed on behalf of this Board to issue a certificate of election to each of the successful candidates.
